MINUTES OF THE NATIONAL PARK CORVETTE CLUB MEETING April 28, 2022

Robert Louton brought up a dangerous design flaw in c6 and c7's. There can be a situation where the door will not open if the electrical power is slightly drained. The solution is to pull the lever next to the seat and the door will open.
